ADE/Charter Board

- AZ State Board for Charter Schools has received our fiscal year 2019 audit reporting package for review of operational performance based on the Board's 2014 framework.
- ADE is now requiring LEA's to upload an electronic copy of the completed audit materials into their grants management system.
- ADE has reported that Liberty has passed the first year of increased proficient performance on AZ Merit
 combined ELA and Math scores in the economically disadvantaged subgroup. We have one more year to
 increase subgroup achievement to be exited as a targeted support and improvement school.

Events/Issues/Considerations

- Mr. Ruben Castro has begun the Arizona Youth Partnership program "Loving My Future." There are 13
 participants involved in health relationship training, pathways coaching and education and career
 exploration. Students who complete the program will earn a quarter credit.
- The annual financial audit completed by Henry Fortino and the annual financial report for FY2019 are
 available for review. The 2019 AFR with supporting documentation; 301 bonus narrative, school level
 reporting page as well as the signature page has been submitted with received verification from ADE on
 October 14th and 15th. Per ADE instructions, we have also provided a link on our website where our AFR
 can be viewed.
- Updates will be provided for Impact Aid field review status. We have not yet received any monies. I have been informed that after our meeting on 10/17 on the IPP Questionnaire items have been cleared, we will begin receiving funding.
- I am seeking authorization from the Board to sell our 2002 Ford bus while is still in good condition after replacing tires and radiator and before we incur further repairs. I would also like to take off the insurance; discussion.
- Since we are trying to build our bank account, and are anticipating another 5% teacher salary increase, I am asking the Board to consider refraining from approving annual longevity bonuses unless there is a surplus of funding in our regular account of \$150,000 or more; after monthly budget expenses have been met; discussion.
- Proposals for gas furnaces and replacement of conduit system for fire alarm system are being forwarded to Holy Angels' Parish for diocesan grant application.
